Dumpster Permits are Required.

Eastampton Township requires homeowners or contractors to obtain a dumpster permit for construction projects or house clean outs. An application and fee in the amount of \$25.00 must be submitted 14 days prior to date of dumpster delivery for approval by the Zoning Officer.

The application will soon be available online through GovPilot, and until then the application can be found at <u>Projects Requiring Permits | Eastampton New Jersey</u>.

Ordinance 2010-7 Section II (3)(a) No temporary storage unit shall be placed or maintained by any private party on any Township property, street or right-of-way. Section II (3)(b) Portable storage units are prohibited from being placed on or in the front yard of a property and shall only be permitted in the driveway of the property at the furthest accessible point from the street. All locations must be paved off-street surfaces. Section II(5) No portable storage unit shall be used to store solid waste, construction debris, demolition debris, recyclable materials, business inventory or commercial goods, except as may be approved by permit. Section II(6) Storage of hazardous materials within the portable storage unit is prohibited.

Permit for PODS only may be extended for an additional \$25.00 fee for an additional 30 days. Applicant

must apply prior to date of expiration. Extensions shall not exceed 90 days.

RESIDENT CORNER

Tips for Residents to Follow During Winter Weather Advisories and Storms.

- Be aware of parking regulations and **once snow has begun, remove all vehicles from roadways to enable plow trucks to clear the roads**.
- In general, it is helpful to park vehicles in garages and driveways wherever possible and not on the street during a storm to improve street snow clearing.
- Remove accumulated snow from abutting sidewalks to assist neighbor and school student safety.
- When clearing snow be mindful not to shovel snow into roadways or adjoining properties.
- Shoveling out neighborhood fire hydrants is encouraged to allow for quick location and access in the event of an emergency. Residents should be aware of fire hydrant locations and street address signs that could become inaccessible due to snow accumulation.
- Unless officially authorized, residents should never assume that frozen ponds or lakes are suitable for skating or other recreational activities.

Residents Are Reminded That All Dogs over 7 Months of Age Are Required to be Licensed Each Year. We began our new online dog licensing on January 1, 2022. Please go to 2022 Dog Licensing Available Online! | Eastampton New Jersey to completely license your dog from the warmth of your home, at any time! The cost for the months of January and February

is \$10.00 for a neutered/spayed dog and \$13.00 for a non-neutered/spayed dog.

A <u>\$10.00 additional fee will be assessed for each dog beginning on March 1</u> as per Ordinance 2021-5. You can also drop off or mail your dog license application and payment along with a self-addressed stamped envelope to receive your license by mail. Or we have a Drop Box here at the Manor House to pick up your dog license at any time. Please ensure your dog's rabies vaccination does not expire before November 1, 2022 or the dog license cannot be issued as per NJ state law.

<u>Animal Control personnel are permitted to inspect current licenses for all dogs</u> residing within the Township. Introduced: March 8, 2021 Adopted: March 22, 2021

ORDINANCE NO. 2021-5

TOWNSHIP OF EASTAMPTON BURLINGTON COUNTY

AN ORDINANCE AMENDING CHAPTER 145-14 (D) OF THE EASTAMPTON TOWNSHIP CODE REGARDING FEES; RENEWAL AND EXPIRATION

BE IT ORDAINED, by the Township Council of the Township of Eastampton, in the County of Burlington and State of New Jersey, as follows:

SECTION I.

The Township Council hereby amends Chapter 145-14 (D) of the Township Code regarding "Fees; Renewal and Expiration" to now read as follows:

Chapter 145-14 (D)

D. In the event that a person required to apply for a dog license by this article fails to apply for said dog license by March 1st of any year, the person shall pay a late fee of \$10.00 for each month that the license is not obtained. Said late fee to be cumulative and to be charged after the first day of the month, for that month, regardless of when the license is obtained during the month of obtaining the license.

SECTION II. Repealer, Severability and Effective Date.

- 1. **Repealer.** Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- 2. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- 3. Effective Date. This Ordinance shall take effect on March 1, 2022 and upon proper passage in accordance with the law.

Adoption: March 22, 2021



Streetlight Outages.

Single Use Plastic Laws.

A provision of New Jersey's commitment to reduce plastics pollution statewide went into effect **Thursday**, **Nov. 4** when food-service businesses provide single-use plastic straws to a customer **only upon request**. For more information you may view the press release <u>here</u>.

On November 4th, 2020, Governor Murphy signed S864, the nation's strictest single use plastics and paper ban. **Beginning in May 2022**, both plastic and paper singleuse bags, as well as disposable food containers and cups made from polystyrene foam, will be banned statewide This bill is a significant step to reduce harm and pollution that these products cause to our environment.

Approximately 9 million scrap auto and truck tires and countless scrap bicycle tires are generated every year in New Jersey. That's a lot of scrap rubber to manage. But, what if a new type of tire was invented that never went flat? Well, that has happened. The tires developed by NASA for use on lunar and Mars Rover missions are elastic like rubber yet strong like titanium. They exhibit perfect shape memory without ever going flat. 
