TAX COLLECTORS CORNER


Fourth quarter property taxes are due on November 1, 2022. Payments must be received by November 10th to avoid interest charges. As a reminder, payments can be made in person or by mailing to the Eastampton Township Tax Collector's Office, 12 Manor House Court, Eastampton, NJ 08060.

You may also utilize the secured drop box at that same location. For your added convenience tax bills may be viewed and payments can also be made by credit card, debit card or electronic check (e-check) at <u>WIPP (edmundsassoc.com)</u>

TAX SALE INFORMATION. All unpaid property taxes, MUA or other municipal charges which remain unpaid as of November 11, 2022 are subject to the annual Municipal Tax Sale scheduled for **December 29**, 2022.

All outstanding charges must be paid by <u>November 10, 2022</u> to avoid the scheduled tax sale.

VOTING CORNER

General Election is on **Tuesday, November 8, 2022** For further information visit <u>New Jersey Department of</u> <u>State - Division of Elections - NJ Voter Information Portal</u> to reach the New Jersey Voter Information Portal, or call 1-877-NJ-VOTER (1-877-658-6837) with any voting questions.



You may return your ballot by placing it a ballot drop box like the one pictured here. A ballot drop box is a secure, locked structure operated by election officials where voters may deliver their ballots from the time they receive them in the mail **up to the time polls close at 8 pm on Election Day, November 8, 2022.** There will be at least 10 drop boxes located throughout each county, which will be available 24 hours a day. A ballot drop box has been installed in Eastampton at 12 Manor House Court, and additional Burlington County locations can be found at: <u>NJ DOS - Division of</u> <u>Elections - Secure Ballot Drop Box Locations</u>.

Top 5 Things To Know About In-Person Early Voting

Here are the answers to five common questions about in-person early voting for the General Election:

1. WHAT IS IN-PERSON EARLY VOTING?

This option enables all registered voters to cast their ballot **in person, using a voting machine, during a nine-day period prior to Election Day.** You can choose to vote, in person, when it's most convenient for your schedule.

2. WHERE CAN I ACCESS IN-PERSON EARLY VOTING?

- No matter where you live in the county, you can vote your specific ballot at any of **your** county's designated in-person early voting locations.
- Find your county's locations at VOTE.NJ.GOV.

3. WHEN CAN I ACCESS IN-PERSON EARLY VOTING?

- In-person early voting locations will be open Saturday, October 29 through Sunday, November 6.
- Hours will be **Monday-Saturday, 10:00 a.m.-8:00 p.m. and Sunday, 10:00 a.m.-6:00 p.m.** No appointment is necessary. Accommodations will be made for voters with disabilities.

4. WHAT IF I ALWAYS VOTE BY MAIL, BUT NOW WANT TO VOTE EARLY, IN PERSON, INSTEAD?

• If you are registered to vote by mail in the 2022 General Election, you may cast your ballot during early, in-person voting or **on** election day via a **provisional ballot** which will be provided to you at your early voting location or polling place. Learn more about provisional ballots at **VOTE.NJ.GOV**.

5. CAN I STILL CHOOSE FROM OTHER VOTING OPTIONS?

Yes. You may select, instead, to:

- Apply for a vote-by-mail ballot and return it one of the following ways...
 - Mail: It must be postmarked on or before 8:00 p.m. November 8 and be received by your county's Board of Elections on or before November 14.
 - 2... Secure Ballot Drop Box: Place it in one of your county's secure ballot drop boxes by 8:00 p.m. on November 8. Drop box locations can be found at VOTE.NJ.GOV.
 - **3...** Board of Elections Office: Deliver it in person to your county's Board of Elections Office by 8:00 p.m. on November 8. County Election Officials' contact information can be found at VOTE.NJ.GOV.
- Or, **vote in person** at your polling place, from 6:00 a.m. to 8:00 p.m. on **Election Day, November 8**. Accommodations will be made for voters with disabilities. Go to **VOTE.NJ.GOV** for your polling place, listed on the Polling Locations page.

NOTE: Vote-by-mail ballots CANNOT be returned to your early voting location or polling place.

Here are the 3 ways you can vote in the upcoming General Election...

1. VOTE-BY-MAIL BALLOT



Registered voters can apply for a **vote-by-mail ballot** by following the instructions found at **VOTE.NJ.GOV** or contacting their County Clerk.

Then, VOTE and RETURN your ballot one of the following ways...

- *Mail:* Your vote-by-mail ballot **MUST** be postmarked on or before **8:00 p.m. on November 8** and be received by your county's Board of Elections on or before November 14.
- Secure Ballot Drop Box: Place your vote-by-mail ballot in one of your county's secure ballot drop boxes by 8:00 p.m. on November 8. Drop box locations can be found at **VOTE.NJ.GOV**.
- Board of Elections Office: Deliver your vote-by-mail ballot in person to your county's Board of Elections Office by 8:00 p.m. on November 8. County Election Officials' contact information can be found at **VOTE.NJ.GOV**.

2. IN-PERSON EARLY VOTING



This option enables all registered voters to cast their ballot **in person, using a voting machine, during a nine-day period prior to Election Day**. You can choose to vote, in person, when it's most convenient for your schedule.

No matter where you live in the county, you can vote your specific ballot at any of **your** county's designated in-person early voting locations. Find your county's locations at **VOTE.NJ.GOV**.

3. AT YOUR POLLING PLACE ON ELECTION DAY



Vote in person at your polling place, from 6:00 a.m. to 8:00 p.m. **on Election Day, November 8**. Accommodations will be made for voters with disabilities.

Go to **VOTE.NJ.GOV** for your polling place, listed on the Polling Locations page.

NOTE: Vote-by-mail ballots CANNOT be returned to your early voting location or polling place.
