Burlington County Recycling Rejection Notifications.

Eastampton Township has been notified by Burlington County Recycling regarding rejection of non-acceptable items in residents' recycling collection. Some common rejections are: Styrofoam, loose trash and trash in bags, recycling is bagged in plastic bags, yard waste, large piles of boxes, construction materials, metal poles, wood, plastic wrap, and pizza boxes.

Please note the residents' address and reason for rejection are submitted to Eastampton Township. Burlington County reserves the right to refuse to collect from addresses that continue to place rejected materials in their recycling.

2020 Census Information The 2020 Census is accessible for everyone. We're making sure that however you choose to respond—online, by phone. or by mail-that the census is accessible. You'll receive an invitation to respond beginning in mid-March. You choose how you want to respond. You can respond online in English or in 12 additional languages. The online questionnaire is accessible, following the latest web accessibility guidelines. We'll also have a video in American Sign Language available to guide you through responding online. You can respond by ${\bf phone}$ in English or in 12 additional languages. You can also respond in English by TDD at 844-467-2020. By mid-April, we'll mail a **paper questionnaire** to every household that hasn't already responded. (Some households will receive a paper questionnaire along with the first invitation in March.) We'll have braille and large print guides available online to assist you with completing the paper guestionnaire. If necessary, you can respond **In person** beginning in mid-May. Census takers will visit all households that have not yet responded. We'll have census takers available who can communicate in American Sign Language and additional languages. When the cancer taker visits to help you respond, you can request that another census taker wists to help in American Sign Language returns, if you prefer. If you prefer, you may also choose to have another member of your household interact with the census taker. Responding is important. A complete count helps ensure that services like Medicare, Medicaid, social security, and public transportation can support those who need them. Responding is safe. The 2020 Census and Confidentiality

Your responses to the 2020 Census are safe, secure, and pro-tected by federal law. Your answers can only be used to produce statistics—they cannot be used against you in any way. By law, all responses to U.S. Census Bureau household and business surveys are kept completely confidential.

Respond to the 2020 Census to shape the future.

Responding to the census helps communities get the funding they need and helps businesses make data-driven decisions that grow the economy. Census data impact our daily lives, informing important decisions about funding for services and infrastructure in your community, including health care, senior centers, jobs, political rep-resentation, roads, schools, and businesses. More than \$675 billion in federal funding flows back to states and local communities each year based on census data.



Your census responses are safe and secure.

The Census Bureau is required by law to protect any personal The Census Bureau is required by law to protect any personal information we collect and keep it strictly conditionatia. The Census Bureau can only use your answers to produce statistics. In fact, every Census Bureau employee takes an oath to protect your personal information for life. Your answers cannot be used for law enforcement purposes or to determine your personal eligibility for auvanced benefit. government benefits.

By law, your responses cannot be used against you.

By law, your census response cannot be used against you by any government agency or court in any way—not by the Federal Bureau of Investigation (FBI), not by the Central Intelligence Agency (CIA), not by the Department of Homeland Security (DHS), and not by U.S. Immigration and Customs Enforcement (ICE). The law requires the Census Bureau to keep your information confidential and use your responses only to produce statistics.

There are no exceptions.

The law requires the Census Bureau to keep everyone's informa-The law requires the Census Bureau to keep everyone's informa-tion confidential. By law, your responses cannot be used against you by any government agency or court in any way. The Census Bureau will not share an individual's responses with immigration enforcement agencies, law enforcement agencies, or allow that information to be used to determine eligibility for government benefits. Title 13 makes It very clear that the data we collect can only be used for statistical purposes—we cannot allow It to be used for anything else, including law enforcement.

It's your choice: you can respond securely online, by mail, or by phone.

You will have the option of responding online, by mail, or by phone. Households that don't respond in one of these ways will be visited by a census taker to collect the information in person. Regardless of how your respond, your personal information is protected by law.

Your online responses are safe from hacking and other cyberthreats.

The Census Bureau takes strong precautions to keep online responses secure. All data submitted online are encrypted to protect personal privacy, and our cybersecurity program meets the highest and most recent standards for protecting personal information. Once the data are received, they are no longer online. From the moment the Census Bureau collects responses, our focus and legal obligation is to keep them safe.

We are committed to confidentiality.

At the U.S. Census Bureau, we are absolutely committed to keep ing your responses confidential. This commitment means it is safe to provide your answers and know that they will only be used to paint a statistical portrait of our nation and communities.

Your responses to the 2020 Census are safe.

Your response to the 2020 Census are protected by law. Under Title 13 of the U.S. Code, the U.S. Census Bureau cannot release any information that identifies you individually. Every Census Bureau employee and contractor is sworn for life to always protect your information. Violating that oath carries stiff penalties for all Census Bureau workers — a fire up to \$250,000 and/or up to five years in prison.

The Census Bureau uses your information for statistical purposes only, such as helping to inform decisions for new hospitals, schools and roads

Responses to the 2020 Census are secure. The Census Bureau has a team of cybersecurity experts who monitor and protect all agency technology around the clock. Our cybersecurity meets the highest standards for protecting your information. From the moment we collect your responses, our goal — and legal obligation — is to keep them safe. The Census Bureau's technology is protected by strong authentication and extended and with "Unclud down" or that it can and be accessed by fully vetted authorization methods and is fully "locked down" so that it can only be accessed by fully vetted individuals who are trained in data and cyber security. These individuals make sure we keep pace with evolving threats and security advancements.

No matter how you respond, your information remains protected. The Census Bureau designed the information collection process with layers of security to ke information safe and secure.

Whether you respond online, by phone, by mail, or if a census employee comes to your door, you Whenery you respond online, by phone, by mail, or it a census employee comes to your door, your information is collected, transmitted and kept secure throughout the process. When you are on our secure website, you can verify it is alle by making sure the address begins with HTPS' and includes a lock symbol. If you're vitiled by a census employee, know that the technology they use has the same stong security controls, and is fully compliant with the standards mandated for federal systems.

The Census Bureau works with the federal intelligence cyber community and industry experts to stay abreast of emerging cyber threats to continuously update protections and safeguards for your information

Why We Ask

The 2020 Census is easy. The questions are simple.

The census asks questions that provide a snap-shot of the nation. Census results affect your voice in government, how much funding your community receives, and how your community plans for the future.

- When you fill out the census, you help:
- Determine how many seats your state gets in Congress. Guide how more than \$675 billion in federal
- funding is distributed to states and commu-nities each year. Create jobs, provide housing, prepare fo
- emergencies, and build schools, roads and hospitals,

POPULATION COUNT (NUMBER OF PEOPLE LIVING OR STAYING)

We ask this question to collect an accurate count of the number of people at each address on Census Day, April 1, 2020. Each decade, census results determine how many seats your state gets in Congress. State and local officials use census counts to draw boundaries for dis-tricts like congressional districts, state legisla-tive districts, and school districts.

ANY ADDITIONAL PEOPLE LIVING OR STAYING

Our goal is to count people once, only once, and in the right place according to where they live on Census Day, Keeping this goal in mind. we ask this question to ensure that everyone living at an address is counted.

OWNER/RENTER

We ask about whether a home is owned or rented to create statistics about

homeownership and renters. Homeownership rates serve as an indicator of the nation's econ-omy and help in administering housing pro-grams and informing planning decisions.

PHONE NUMBER

We ask for a phone number in case we need to contact you. We will never share your number and will only contact you if needed for official Census Bureau business.

Why We Ask

The 2020 Census is easy. The questions are simple.

NAME

We ask for names to ensure everyone in the house is counted. Listing the name of each person in the household helps respondents include all members, particularly in large house holds where a respondent may forget who was counted and who was not

SEX

We ask about the sex of each person to cre-ate statistics about males and females. Census data about sex are used in planning and fund-ing government programs, and in evaluating other government programs and policies to ensure they fairly and equitably serve the needs of males and females. These statistics are also used to anderen law, creutistican and exilian used to enforce laws, regulations, and policies against discrimination in government programs and in society.

AGE AND DATE OF BIRTH

We ask about age and date of birth to under-stand the size and characteristics of different age groups and to present other data by age. Local, state, tribal, and federal agencies use age data to plan and fund government programs that provide assistance or services for specific age norus excha schildren working-age. age groups, such as children, working-age adults, women of childbearing age, or the older population. These statistics also help enforce laws, regulations, and policies against age discrimination in government programs and in society.

HISPANIC, LATINO, OR SPANISH ORIGIN

We ask about whether a person is of Hispanic, Latino, or Spanish origin to create statistics

RACE

We ask about a person's race to create statistics We ask about a person's race to create statistics about race and to present other statistics by race groups. The data collected in this question are needed by federal agencies to monitor com-pliance with antidiscrimination provisions, such as under the Voting Rights Act and the Civil Rights Act. State governments use the data to determine congressional, state, and local voting districts. districts.

WHETHER A PERSON LIVES OR STAYS SOMEWHERE ELSE

Our goal is to count people once, only once, and in the right place according to where they live on Census Day. Keeping this goal in mind, we ask this question to ensure individuals are not included at multiple addresses.

RELATIONSHIP

We ask about the relationship of each person in a household to one central person to create estimates about families, households, and other groups. Relationship data are used in planning groups. Relationship data are used in planning and funding government programs that provide funds or services for families, people living or raising children alone, grandparents living with grandchildren, or other households that qualify for additional assistance.

2020 Census FAQ

What Is the census?

The census is a count of every person who lives in the United States and its territories. It happens every 10 years. In early 2020, you will be asked to count everyone who lives in your home as of April 1. Responding to the 2020 Census is a chance to shape your future.

What's In It for me?

Census data gives community leaders vital information to make decisions about building inform where over \$675 billion is distributed each year to community centers, opening businesses, and planning for the future. communities nationwide for clinics, schools, roads, and more.

Is my information safe?

Is my information safe? Your responses to the 2020 Census are safe, secure, and protected by federal law. Your answers can only be used to produce statistics. They cannot be used against you by any government agency or court in any way—not by the FBI, not by the CIA, not by the DHS, and not by ICE.

When can I respond to the census?

In early 2020, every household in America will receive a notice to complete the census online, by phone, or by mail. In May, the U.S. Census Bureau will begin following up in person with households that have yet to respond.

What will I be asked?

You will be asked a few simple questions, like age, sex, and the number of people who live in your home, including children.

What won't be asked?

The census will never ask for Social Security numbers, bank credit card numbers, money or donations, or anything related to political parties.
