Dog Licensing



to be Licensed Each Year. Dog licenses are valid for the current calendar year and expire annually on December 31. Licensing maybe done by mail with a self-addressed stamped envelope included for return of your license, or in person. The cost is \$10.00 for a neutered/spayed dog and \$13.00 for a non-neutered/spayed dog. A \$2.00 per month additional fee will be assessed for each dog registered after January 31. Animal Control personnel are permitted to inspect current licenses for all dogs residing within the Township. Licensing information may be obtained in person at the Manor House or by calling (609) 267-5723, ext. 200.

Please note that the rabies vaccination must be valid through November 1, 2020 by NJ State Law to obtain the license

Burlington County Animal Shelter Free Rabies Clinic will be held <u>Tuesday</u>, <u>February 18th</u>, from <u>3:00 PM to 4:00 PM</u> at 35 Academy Dr, Westampton, NJ 08060.

They advise not arriving any earlier then 2:30 PM as the Vet does not start to administer the vaccine until 3:00 PM. Please bring proof of prior rabies vaccine (tag, certificate, township license, vet records) so the animal may receive a three year booster, without proof of prior vaccine the vaccine will be marked for one year. The line will form in the front of the building outside so please dress accordingly to the weather.

Automated Trash Truck- We Hear You

During the transition to the automated trash collection please know we hear and see your concerns regarding this new system. We have been collecting data regarding the new trash carts that have been delivered. In the coming weeks those who would like a second cart may purchase one for \$60.00. We have begun to compile a list for the residents interested in purchasing a second cart. Please know you are on the list, and we will notify you in the coming weeks.

Any resident that would like to purchase a second cart please contact us at 609-267-5723 ext. 200 to be added to the list. The Township is looking to order smaller carts for those residents that have expressed an interest, and the smallest cart size available to order is 64 gallons. This will take longer than the purchase of a second 96 gallon trash cart as the minimum cart order that can be placed is 54, and we have not reached that minimum quantity at this time. Automated Trash Collection Begins- Please utilize the new trash cart for automated truck collection beginning on <u>February 4, 2020</u>. Please see the Guidelines and Cart Care Instructions below.

Solid Waste Collection Guidelines

Solid Waste collection will continue to be provided as it is currently to residents of Eastampton once per week. Please observe the following guidelines to keep your collection service running smoothly.

Your cart should be placed at the curb in front of your residence either the night before your scheduled collection day or no later than 6:00 am on your collection day.

Bag and tie your trash inside the 96-gallon trash cart.

Cart Care

Your new trash cart is designed for ease of maintenance. To clean, simply rinse with water from time to time and let it dry in the sunlight with the lid open. Do not place paints, solvents, acids, gasoline, oil, hot ashes, medical waste, exposed needles, sand, soil, rocks or concrete in your cart.

Cart Ownership

Carts are the property of Eastampton Township. They have been registered to your address and are not to be removed from that property.





Your Pickup Schedule service will remain the same day as your current service.

Eastampton Township Solid Waste ROLL OUT CART INSTRUCTIONS

NOTE: This cart, by consignment of serial number, is assigned to this address. The cart is an audited asset that belongs to Eastampton Township and shall remain at this address no matter the occupant. Destruction or theft of the trash cart shall be considered a criminal offense.

WHAT YOU NEED TO KNOW

- Place cart approximately five (5) feet from the nearest public road without blocking the mailbox.
- Please do not park your car in front of cart on pick up day.
- Trash service will remain on the same day as your current collection day.
- Extra trash or bags outside the cart will not be collected.

CART RULES

- Eastampton Township will only dump carts provided by Eastampton Township Solid Waste.
- Garbage shall be bagged before being placed in the cart and the accumulated weight of all materials in the cart shall not exceed 300 pounds.
- Loose garbage will NOT be picked up.
 Loose garbage is a disease and injury
 risk to our collection personnel, impedes productivity and creates litter
 that can easily become airborne and
 violates the NJDEP Permit.
- An Additional cart may be purchased for \$60.00. Call 609-267-5723 x200 for further information.
- Waste such as sofas, mattresses, recliners, and other bulky waste shall be collected on your respective bulk days.

DO NOT PLACE IN CART

- Bricks, Asphalt, concrete.
- Any wood materials.
- Heavy metal objects.
- Household hazardous waste including but not limited to paints, paint thinner, household chemicals, pesticides, herbicides, etc.
- Liquid waste (including grease, cooking oil, etc.)
- Large batteries (including automobile, tractor, lawnmower, etc.)
- Shingles, sheet rock, toilets, sinks, rugs, bulky waste, or rubbish that may cause damage/harm to the cart or collection personnel through either excessive weight or sharp protrusions.
- Stable matter (including hay and manure), needles, body fluids, or any other material that may harbor infectious diseases.

"No Knock" Solicitation

The Township recognizes the need to license and regulate peddlers and solicitors who are conducting business within the Township, as complaints from residents have been received. The Township seeks to prevent peddlers and solicitors from accessing homes of residents that do not wish to be disturbed through **Ordinance 2019-20**. *Chapter 374* of the Township Code amends the license fee for peddlers and solicitors in Eastampton, and establishes a "No-Knock" list for residents.

- Each peddler seeking to solicit in Eastampton Township would apply for a license at the Eastampton Police Dept. Once approval has been granted they would pay a fee of \$50 for the period of January 1 to December 31 of each calendar year.
- Each approved peddler or solicitor's license must then be taken to the Municipal Clerk's
 office, where they would then obtain a copy of the most current version of the "No Knock"
 list.
- Residents may register their name and address with the Township Clerk for placement on the "No Knock List," indicating they do not want any persons so licensed to approach the registered home and/or seek personal contact with the occupants.
- Once the resident's name has been added by the Township Clerk to the "No Knock List," the resident shall be permitted to post a "No Knock" sticker on the front door of his/her home to advise the solicitor and canvasser. This adhesive sticker will be provided to the resident by the Township Clerk.
- It shall be unlawful for any licensed peddler or solicitor to approach a registered home and/or seek personal contact with the occupants if the resident has registered on the "No Knock List" or posted a "No Knock" sticker as provided by the Township Clerk. Any person violating or failing to comply with the provisions of **Ordinance 2019-20** shall be subject to penalty set forth in Chapter 1, Article II, Penalties for Violations, of the Township Code.
- Any resident interested in being added to the "No Knock List" please complete the
 attached form and return to the Township Clerk at 12 Manor House Court, Eastampton
 NJ 08060. Once the form has been received the Township Clerk's office will mail the "No
 Knock" sticker to their address to be placed on the front door of the residence. Registration
 on the "No Knock" list shall expire in 5 years, unless renewed by notifying the Township
 Clerk.

Tips for Residents to Follow During Winter Weather Advisories and Storms:

- Be aware of parking regulations and once snow has begun, remove all vehicles from roadways to enable plow trucks to clear the roads. In general, it is helpful to park vehicles in garages and driveways wherever possible and not on the street during a storm to improve street snow clearing.
- Remove accumulated snow from abutting sidewalks to assist neighbor and school student safety. When clearing snow, be mindful not to shovel snow into roadways or adjoining properties.
- Shoveling out neighborhood fire hydrants is encouraged to allow for quick location and access in event of an emergency. Residents should be aware of fire hydrant locations and street address signs that could become inaccessible due to snow accumulation.
- Unless officially authorized, residents should never assume that frozen ponds or lakes are suitable for skating or other recreational activities
