Observed Holidays



Municipal Offices are closed on Friday, July 3, 2020 in Observance of Independence Day. We will reopen on Monday, July 6, 2020 at 8:30 a.m.

As we approach the **July 4th** holiday weekend, we wanted to send out a message to our residents in regards to fireworks. We encourage the residents of Eastampton Township to enjoy the holiday weekend in a responsible way while celebrating and spending time together. With many venues cancelling fireworks displays this year, we also understand that some will take it upon themselves to engage in setting off fireworks at their own residences.

We would like to remind everyone of **Township Ordinance** 343-1. It shall be unlawful for any person to make, continue or cause to be made or continued any loud, unnecessary or unusual noise or any noise which either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others within the limits of the Township. Respectfully, **Title 21** (Explosives and Fireworks) of **New Jersey State Code**, specifically **21:2-6** Dangerous fireworks prohibited, states: it shall be unlawful to manufacture, sell, transport, or use dangerous fireworks within the state. "Dangerous fireworks" include:

- Toy torpedoes containing more than 5 grains of an explosive composition.
- Paper caps containing more than .35 grain of explosive composition.
- Firecrackers or salutes exceeding 5 inches in length or 3/4 inch in diameter.
- Cannons, canes, pistols or other devices designed for use otherwise than with paper caps.
- Any fireworks containing a compound or mixture of yellow or white phosphorous or mercury.
- Any fireworks that contain a detonator or blasting cap.
- Fireworks compositions that ignite spontaneously or undergo marked decomposition when subjected for 48 consecutive hours to a temperature of 167 degrees Fahrenheit.
- Fireworks that can be exploded en masse by a blasting cap placed in one of the units or by impact of a rifle bullet or otherwise.
- Fireworks, such as fuses, containing a match tip, or head, or similar igniting point or surface, unless each individual tip, head or igniting point or surface is thoroughly covered and securely protected from accidental contact or friction with any other surface.
- Fireworks containing an ammonium salt and a chlorate.

We ask that everyone please be considerate of your fellow neighbors and their animals. Many residents have young children and animals that may become anxious and frightened at the sound of fireworks. Please also remember that fireworks are dangerous explosive devices that can lead to severe injuries and even lead to death.

On behalf of the Township of Eastampton we wish you a happy and healthy 4th of July. Please enjoy it responsibly!

Municipal Building Reopening to the Public July 6, 2020

Face coverings are mandatory for anyone to enter Eastampton Municipal buildings. Once entering the Manor House M-F from 8:30-4:30 check in is required with the Office Assistant Rupi Swaitch at the 1st floor window. Social distancing recommendations of 6' must be adhered to. Please note that due to New Jersey Governor Phil Murphy's Executive Order No. 152 the maximum capacity for the building is 25%, which is a total of 12 people including staff members. If the capacity has been met you will be required to wait outside until someone exits. Please see the following list of staff members and hours of operation for assistance:

Primary Election

Residents can check their voter registration status online by using the "Registration Resources" link on the County Clerk's Burlington County Clerk's website page. http://www.co.burlington.nj.us/1725/Registration-Resources

Reminder, residents who are currently age 17 can sign up now to automatically register to vote when you turn 18. Seventeen-year olds who sign up for automatic registration on or before June 16th, and who will turn 18 by July7th, are eligible to participate in the Primary Election.



July 7, 2020

Polls open 6:00 am- 8:00pm

- In direct response to the COVID-19 Pandemic and in accordance to Executive Order 144 the 2020 Primary election will be held on July 7, 2020
- Election will primarily be VOTE-BY-MAIL
- If you go to a polling location you will ONLY be allowed to do a **PROVISIONAL BALLOT**
- All voters will receive a vote by mail ballot and return postage paid envelope
- All active Republicans and Democrats will receive a vote by mail ballot and return postage paid envelope
- All Unaffiliated and Inactive voters will receive a vote by mail application and return postage paid envelope
- Ballots **CANNOT** be returned to polling locations
- ONLY VOTERS WITH DISABLITIES preventing them from vote using a paper ballot will be able to vote on ADA-accessible machines at polling location
- There will be limited polling locations available
- The Deadline to Register to vote was June 16, 2020

Township Council Meeting will be held on Monday, July 20th. Land Use Planning Board Meeting is Wednesday, July 15th at 7:30 p.m. PLEASE NOTE: Meetings will be held telephonically until further notice. Log on information will be posted on our website along with the Agendas.

Attention Residents: All outdoor work for new or replacement fencing, sheds, driveways, pools etc. needs to have zoning and/or construction approvals. Even if the municipal building is closed to the public the Zoning and Construction offices are still operating and enforcing.

Resident Reminder: We need everyone's cooperation to help keep Eastampton neat and tidy. Please adhere to the schedule for your area for brush or bulk pick-up. Anything is to be placed out **only on the night before your scheduled pickup day**. Please note that as per Ordinance 2019-17 <u>no house clean outs</u> will be accepted for bulk pick-up by the Public Works department.

Ordinance 2019-17. 444-2 Section D.

The Township will collect bulk trash on a monthly basis. Bulk shall consist of items such as old furniture, bedding, carpeting, pool covers and metal items such as bicycles. No waste materials of any kind that are generated from commercial activities or businesses, including handyman, repair services, retail store, offices, real estate agencies, landlords, contractors, agricultural enterprises. Residents doing minor repairs to the primary residence may put out small amounts of debris on their bulk day. No house/rental clean outs will be accepted.

Certificate of Continued Occupancy Inspection
Eastampton Township is a growing community that transitioned from a paper-based CCO application and inspection system to GovPllot's cloud-based digital platform.

Challenge

Eastampton Township relied on paper-based application, inspection, and record-keeping to administer the town's CCO process. As the township grew, the inefficient process led to redundant communication with residents, excessive phone calls and walk-ins, lost paperwork, an expansive filing system in the basement of the municipal building, a decrease in employee productivity, and frustrated constituents.

Solution

Officials from Eastampton engaged GovPilotto provide a digital process. Now, residents and local real estate agents can request records and apply for CCO, directly through a digital form accessed via the township's website. Automated status emails keep applicants informed through every step of the process, and employees can search records instantly. Today, the township inspector uses a tablet to inspect properties, eliminating cumbersome paperwork and the need to travel back and forth to the office for filing.

Results

50% to 1% of Day

With GovPilot's cloud-based digital forms the Clerk's department reduced time spent on phone and email communication with residents from half of their day to just a few minutes per day.

5 hrs per week

Replacing paper based inspections with GovPilot's cloud-based inspection app accessible via mobile devices has saved the inspector five hours perweek in travel, paperwork, and communication with staff.

30 mins to 30 sec.

Prior to GovPilot, employees had to search for paper records filed in the basement and relay that information to a colleague or resident. Now, digital records are accessible in seconds by city employees, from any device at any time.

The COVID-19 Emergency Rental Assistance Program (CVERAP) will provide temporary rental assistance to low- and moderate-income households that have had a substantial reduction in income or became unemployed due the COVID-19 pandemic. The COVID-19 Emergency Rental Assistance Program (CVERAP)

Applicants may be eligible for a maximum of up to six months of emergency rental assistance. CVERAP Pre-applications will only be accepted online.

The Enrollment Period is Monday, July 6, 2020, at 9:00 am until Friday, July 10, 2020, at 5:00 pm

All participants will be reviewed at the three-month interval to see if they are still in need of assistance. Persons applying must meet all applicable CVERAP income and eligibility requirements. You must be eighteen (18) years of age or older to apply or be an emancipated minor. Only one (1) pre-application per household will be accepted. All participants will be selected through an online lottery process. Anyone selected for the program must meet the following requirements:

	Be a New Jersey resident and rent a unit in New Jersey
	Rent must be current as of March 2020; this program will not assist with



New salon and spa opening in Eastampton

A new business, the Bella Bar Salon and Spa, is ready to open in Eastampton this July.

 ${\it EASTAMPTON}$ — Josie Russo is a full-time nurse, but she has always wanted to open her own salon.

Now, with the upcoming opening of the <u>Bella Bar Salon and Spa</u>, Russo will get to realize her dream.

This July, Russo and two co-owners, her brother Jack Russo and their associate, Denise Blattenberger, will open the new salon and spa at 1302 Monmouth Road in the township.

The Russos and Blattenberger will set up shop inside a roughly 1,400-squarefoot space in Mart's Shopping Center.

When it opens, the salon will have between six and eight full-time hairdressers, Josie Russo said. Eventually, she added, the owners are hoping to hire four more staff members for skin, nails, massages and tanning.

All of the hairdressers live in Burlington County, besides one who lives in Philadelphia.

Eastampton's newest salon is only waiting on one more inspection, from the state Board of Cosmetology, before it can open for business.

But the board has been closed due to the coronavirus pandemic, and it still has not reopened, even though the state allowed barber shops and salons to reopen on Monday.

Josie Russo is hoping the board reopens soon, so the Bella Bar Salon can hit its July target.

"We just finished construction a couple weeks ago," Russo said in early June. "But we can't open without that inspection."

No matter how long it takes for the inspectors to come, the co-owners are willing to wait. They all have other jobs and incomes they can depend on in the meantime.

"I've been working as a nurse," Josie Russo said. "Thank goodness I've had a job and I've been able to pay the bills."

Russo plans on continuing to work as a nurse even after the salon opens. But she also wants to be the type of small business owner who is available 24/7, and present at the location during her off hours.

Once the salon opens, between working as an essential employee during the pandemic and establishing a small business with social distancing restrictions, Russo may literally be working 24/7. But she is OK with that, because she's committed to making her dream work.

She's dedicated because she has always prided herself on empowering other women. That's why she always wanted to run a salon. It offers female workers the chance to build up their own customer bases.

As a nurse, Russo has always been the one to encourage female co-workers to go back to school or keep plugging away for that promotion.

So when the space in Mart's Shopping Center became available, Russo noticed because her family's business, Russo's Pub & Italian Restaurant, is in the same shopping center.

She recognized that the space offered her a chance to do more than just encourage other women.

"I always take the opportunity to help," she said. "The opportunity presented itself."

As a full-time nurse who lives in a different town, Cream Ridge in Monmouth County, Russo will only be able to physically watch over her business on a limited basis.

That's where Blattenberger comes in.

The co-owner, who also works for Russo's Pub & Italian Restaurant, has been working in the salon industry for more than 20 years, including as a manager.

Blattenberger even grew up in the industry. As a young girl, she would help out at her aunt's salon in Wildwood, sweeping the floors, cleaning the towels and watching her aunt, Barbara Ann Flacco, "do her thing," as Blattenberger put it.

"It's all about the inspiration that when someone sits in their chair, you can make their day," she said. "You can make them feel beautiful."

Russo is confident that, with Blattenberger in charge day to day, the salon will thrive.

"It's her expertise," Russo said. "She has been doing this for over 20 years."

Together, the co-owners are bullish about the business because of the area, too.

"Eastampton is doing a great job building up the township with the apartments, the condos," Blattenberger said.
