County Chief's meeting, I attended the meeting, nothing of significance was discussed (Finally, meetings are now only an hour long)

Chief's Monthly Round up.....

July was hot, and busy.... we had one day with 4 calls at ECS, it now appears they fixed the alarm system. The guys fixed the oil dry hopper issue on 3411.... probably saved us \$200 with \$2 part from tractor supply.

As for public relations.... We provided an engine and deck gun at ECS for summer school enrichment completion, the kids loved it, running through the over spray (this also doubled out as a training exercise for a pump operator) and the FFs supported a local lemonade stand, a couple kids trying to raise money so they can go on vacation with their families. The fire company donated to the kids.

Members and their families have been hanging the recruitment door hangers (we already have one new member) and will be ordering more to continue to hit each residence in town.

Training wise, FF utilized the Eastampton Place West swimming pool and practiced pool extrication and also practiced with our throw bags (a few residents observed from their balcony's, and we had a few wander to the fence around the pool to watch us train), so we could also classify it as public relations event.

Portable batteries are still on order.

Replacement 3400 is at the dealer, slated for upfitting in mid-august. I had reached out twice before with no response, so I made an unannounced visit and voila truck is in. With the upfitting, we will have to drop off the current chief's vehicle to transfer radios and some other equipment to the new 3400. I will reach out the board and find out what their plans are with old 3400 and 3418.

AEDs are still on order; I spoke with dealer, and he still has his fingers crossed for them to be in his next shipment from the manufacturer.

SCBA (grant purchase) remains on order with no current shipment date.

BoFC....in the storage shed, request to dispose of 1 outdated damaged gas powered Positive Pressure Fan (housing is cracked) and to have the board administrator sell off 1 gas powered PPF. I would keep the third 'youngest' gas powered PPF as a back up for our newer electric fans that are in service on the trucks. These fans have been out of service for a few years now. Also, Request to dispose of expired and un-useable firehose that has failed NFPA testing requirements and are not salvageable.
