DISCUSSION ITEMS:

1. Shared Service Agreement for Public Works Services
Township Council discussed an agreement with Westampton Township for street sweeping for Eastampton Township three times per year for 5 days each time (15 days) in exchange for use of the Township roadside mower for 18 days and \$4,600. This would be for labor cost of the Westampton employees to drive their street sweeping truck.
2. 2024 Road Program
The Township Engineer had provided a revised proposal for Kensington Drive that included the three alternates of Wexford Court, Strathmere Road and Newbury Lane. After discussion Township Council agreed to proceed with items #1-5 of the proposal as a resolution on the February 26th agenda.
