

**ORDINANCE NO. 2017-6**

**TOWNSHIP OF EASTAMPTON  
BURLINGTON COUNTY**

**AN ORDINANCE TO AMEND THE EASTAMPTON  
TOWNSHIP CODE AT CHAPTER 250 "FEES" TO  
ESTABLISH OR AMEND FEES ASSOCIATED WITH RECREATION**

BE IT ORDAINED, by the Township Council of the Township of Eastampton, in the County of Burlington and State of New Jersey as follows:

**SECTION I**

Section 250-2 of the Township Code entitled "Recreation Fees" is hereby amended to add the new fees for Recreation.

Kids Fun Run	\$5	\$15
Park Bench	\$750	\$2,000
After School Programs	\$50 per program	\$200 per program
Summer Clinics/Workshops	\$50 per program	\$200 per program
Food/Candy/Beverages	\$0.25	\$5.00
Toys/Prizes	\$0.25	\$15.00
Workshops/Programs	\$5.00	\$100.00
Special Events	\$10.00	\$200.00

**SECTION II**

Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

**SECTION III.**


This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
